Commitment to achieving Net Zero

The Board of Livewell Southwest approved a Livewell Greener Strategy in March 2022 confirming Livewell Southwest is committed to achieving Net Zero emissions by 2050.

Within this Carbon Reduction Plan, The Livewell Southwest Board are pleased to reaffirm this commitment.

A Greener Livewell Action plan to achieve this has been developed alongside a reference group of Livewell Southwest colleagues. This activity reports into the Sustainability Committee of the Board and has the Chair of Livewell Southwest as the Board champion and the Deputy Chief Executive as the Executive Director champion.

Baseline Emissions Footprint

Baseline emissions are a record of the greenhouse gases that have been produced in the past and were produced prior to the introduction of any strategies to reduce emissions. Baseline emissions are the reference point against which emissions reduction can be measured.

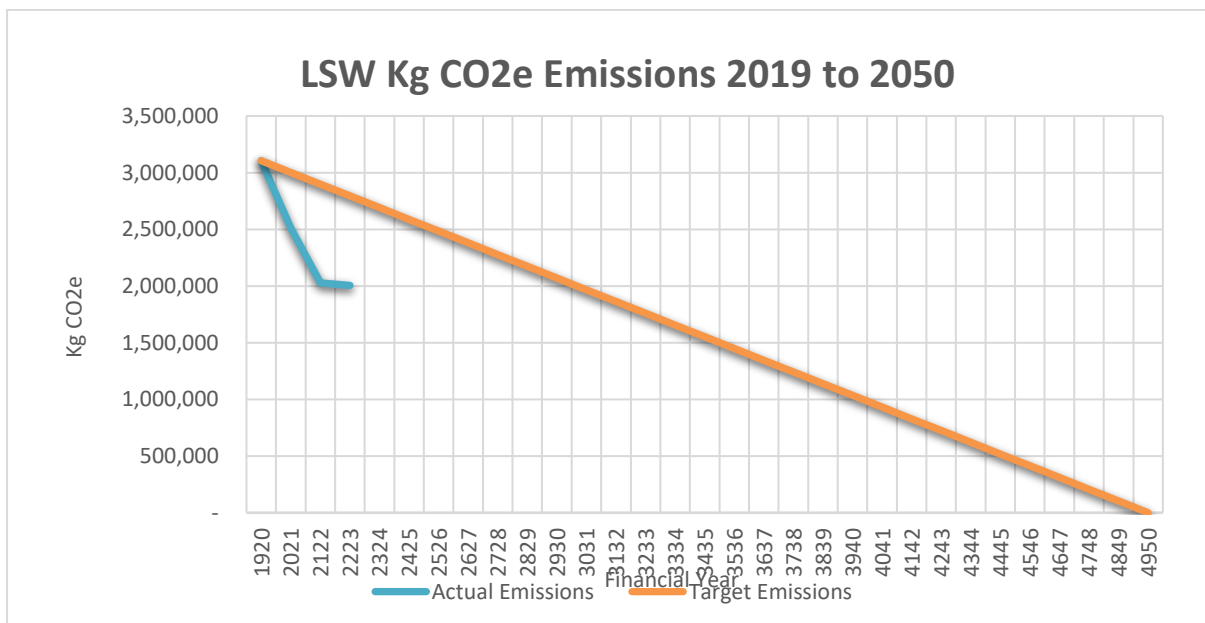

Emissions reduction targets

In order to continue our progress to achieving Net Zero, we have adopted the following carbon reduction targets listed in the graph below.

We project that carbon emissions will decrease over the next five years to **2,000,000** tCO₂e by 2028. This is a reduction of **36%** from the 2019/20 baseline.

Carbon Reduction Projects

Completed Carbon Reduction Initiatives

The following environmental management measures and projects have been completed or implemented since the 2019 baseline. The carbon emission reduction achieved by these schemes equate to **1,099,759 tCO₂e**, a **35%**ge reduction against the 2019 baseline and the measures are in effect when performing the contract.

Completed Carbon reduction projects include:

- Utilities measurements, identifying baseline information for Gas and Electricity usage across the Livewell Estate including engagement with all landlords to seek support to identify capital changes that will reduce emissions.
- E.g. A move of our headquarters to a more efficient reduced carbon emission environment including reduced emissions on electricity with LED lighting and heat pumps.
- Transferring pool car fleet to hybrid vehicles reducing emissions with plans to move to full electric ULEV vehicles.
- Eliminating land fill waste for waste food from our hospital sites.
- New models of care reducing the need for clinical community staff and/or patients travelling to appointments and increasing virtual appointment opportunities.

In the future we hope to implement further measures such as:

- Further reduction of use of Gas and Electricity utilities and transfer to more efficient heating and lighting
- Reduce transport related emissions from clinical staff travelling in the community and office/inpatient based staff travelling to and from their work base.
- Increasing new models of care that reduce the need for staff or patients or families to travel for assessment, treatment, or reviews.
- Implementing plans for Carbon offsetting
